Late Fees and Interest on Overdue Accounts

Any STAND/Strathcona-Tweedsmuir School student account that has not been paid promptly, or in accordance with the fee schedule, and has not made acceptable payment arrangements with the Finance Department, will not be permitted to re-enrol at the school for the subsequent year. Parents/guardians will continue to be liable for the full payment of the annual tuition fees.

Interest, at a rate of 2% per month or 24% per annum, will be charged on the unpaid balance of the account after 30 days. All accounts over 120 days past due will be sent to a collections agency.

Non-Resident Students: International students residing in Canada by virtue of a student visa are not eligible for the Alberta subsidy for resident students. Consequently, these students must assume the total cost of education for each year they attend the School.

Registrations received in June, 2025 are used to determine the 2025 - 2026 Busing routes developed by our busing provider. It is important that you register for this service by June, 2024. **Routes are final as of September 23, 2025 - no changes or refunds will be made.**

Late Fees and Interest on Overdue Accounts

Any STAND/Strathcona-Tweedsmuir School student account that has not been paid promptly, or in accordance with the fee schedule, and has not made acceptable payment arrangements with the Finance Department, will not be permitted to re-enroll at the school for the subsequent year. Parents/guardians will continue to be liable for the full **Interest, at a rate of 2% per month or 24% per annum, will be charged on the unpaid balance of the account after 30 days. All accounts over 120 days past due will be sent to a collection's agency.**
