**Late Fees and Interest on Overdue Accounts**  
 Any STAND/Strathcona-Tweedsmuir School student account that has not been paid promptly, or in accordance with the fee schedule, and has not made acceptable payment arrangements with the Finance Department, will not be permitted to re-enrol at the school for the subsequent year. **Please Note:** The June, 2023 bus deposit ensures that your child will have a seat on a route. Registrations received in June, 2023 are used to determine the 2023 - 2024 Bussing routes developed by Southland Transportation Ltd. It is important that you register for this service by June, 2023. **Routes are final as of September 30, 2023 - no changes or refunds will be made.**

#### **Late Fees and Interest on Overdue Accounts**

Any Strathcona-Tweedsmuir School student account that has not been paid promptly, or in accordance with the fee schedule, and has not made acceptable payment arrangements with the Finance Department, will not be permitted to re-enrol at the school for the subsequent year.
