**Please Note:** The June 2024 bus deposit ensures that your child will have a seat on a route. Registrations received in June 2024 are used to determine the 2024- 2025 Bussing routes developed by Southland Transportation Ltd. It is important that you register for this service by June 2024. **Routes are final as of September 23, 2024 - no changes or refunds will be made.**

#### **Late Fees and Interest on Overdue Accounts**

Any Strathcona-Tweedsmuir School student account that has not been paid promptly, or in accordance with the fee schedule, and has not made acceptable payment arrangements with the Finance Department, may not be permitted to re-enrol at the school for the subsequent year. Parents/guardians will continue to be liable for the full payment of the annual **Interest, at a rate of 2% per month or 24% per annum, will be charged on the unpaid balance of the account after 30 days. All accounts over 120 days past due will be sent to a collections agency.**

**Credit Card Transactions:** All credit card transactions will be subject to a Credit Card Convenience Fee of 2.4%.

**Non-Resident Students:** International students residing in Canada by virtue of a student visa are not eligible for the Alberta subsidy for resident students. Consequently, these students must assume the total cost of education for each year they attend the School. Please contact the school finance office for international tuition fees.
