**Please Note:** The June 2025 bus deposit ensures that your child will have a seat on a route. Registrations received in June 2025 are used to determine the 2025- 2026 Bussing routes developed by the provider. It is important that you register for this service by June 2025. **Routes are final as of September 23, 2025 - no changes or refunds will be made.**

**Late Fees and Interest on Overdue Accounts**  
Any Strathcona-Tweedsmuir School student account that has not been paid promptly, or in accordance with the fee schedule, and has not made acceptable payment arrangements with the Finance Department, may not be permitted to re-enrol at the school for the subsequent year. Parents/guardians will continue to be liable for the full payment of the annual **Interest, at a rate of 2% per month or 24% per annum, will be charged on the unpaid balance of the account after 30 days. All accounts over 120 days past due will be sent to a collections agency.**

**Credit Card Transactions:** All credit card transactions will be subject to a Credit Card Convenience Fee of 2.4%.

**Students Enrolling Mid-year, after September 30, 2025, and Non-Resident Students:**

- **Students enrolling mid-year, after September 30, 2025, are not eligible for the Alberta subsidy for resident students attending Independent School in Alberta. Consequently, as part of their pro-rated mid-year entry tuition, these students will assume the cost of the Alberta subsidy for the year they enroll at the school.**
- **International students residing in Canada by virtue of a student visa are not eligible for the Alberta subsidy for resident students. Consequently, these students will assume the total cost of education for each year they attend the School. Please contact the school finance office for international tuition fees.**
